IN 2014, THE SOCIETY AWARDED OVER \$6.0 MILLION IN GRANTS TO 2,714 STUDENTS TO HELP PAY FOR COLLEGE. IN ADDITION, THE SOCIETY AWARDS MERIT-BASED SCHOLARSHIPS FOR THE HIGHEST ACHIEVING INCOMING FRESHMEN. SELECTION IS BASED ON A STUDENT'S CUMULATIVE GPA, SAT/ACT SCORES, TRANSCRIPTS, ACTIVITIES, AND A WRITTEN ESSAY ON A SPECIFIC TOPIC CHOSEN BY THE SOCIETY. IN 2014, THE SOCIETY AWARDED 15 \$5,000 SCHOLARSHIPS, EQUATING TO AN ADDITIONAL \$75,000 IN ADDITIONAL EDUCATIONAL SUPPORT TO AIR FORCE FAMILIES.

THE ON-BASE AF PERSONNEL WHO HELP ADMINISTER THE PROGRAM CAN ALSO WORK WITH THE AIRMAN TO DEVELOP A FAMILY BUDGET IN AN EFFORT TO HELP THEM STAY FINANCIALLY SOUND AFTER THE ASSISTANCE IS PROVIDED. IN 2014, THE SOCIETY ASSISTED AIRMEN WITH OVER \$9.1 MILLION, EQUATING TO OVER 18,000
