EDUCATION ASSISTANCE - THE GENERAL HENRY "HAP" ARNOLD EDUCATION GRANT PROGRAM PROVIDES NEEDS-BASED EDUCATION GRANTS TO CHILDREN AND SPOUSES OF AIRMEN. IN 2015, THE SOCIETY AWARDED ALMOST \$6 MILLION IN GRANTS TO 2,632 STUDENTS TO HELP PAY FOR COLLEGE. AN ADDITIONAL 19 \$5,000 MERIT-BASED SCHOLARSHIPS WERE AWARDED TO THE HIGHEST ACHIEVING INCOMING FRESHMEN. SCHOLARSHIP SELECTION IS BASED ON A STUDENT'S GPA, SAT/ACT SCORES, ACTIVITIES, AND A WRITTEN ESSAY. THE YOUTH EMPLOYMENT SKILLS (YES) PROGRAM OFFERS HIGH SCHOOL STUDENTS A CHANCE TO VOLUNTEER FOR ON-BASE OPPORTUNITIES TO LEARN VALUABLE WORK SKILLS, EARNING UP TO \$1,500 IN GRANTS FOR COLLEGE. IN 2015, THE YES PROGRAM SPENT AN ADDITIONAL \$131,000 TOWARD STUDENT EDUCATION.

EMERGENCY ASSISTANCE (EA) - THE EA PROGRAM IS PRIORITY NUMBER ONE FOR THE SOCIETY AND IS AIMED TOWARDS HELPING RELIEVE THE FINANCIAL PRESSURES ON AIRMEN AND THEIR FAMILIES BY ASSISTING WITH IMMEDIATE FINANCIAL NEEDS IN AN EMERGENCY SITUATION. SUPPORT IS PROVIDED THROUGH INTEREST-FREE LOANS AND GRANTS, DEPENDING ON THE INDIVIDUAL CIRCUMSTANCES SURROUNDING THE NEED. EA IS PROVIDED FOR BASIC LIVING EXPENSES, EMERGENCY TRAVEL, VEHICLE REPAIRS, FUNERAL COSTS, MEDICAL/DENTAL COSTS, CHILD/RESPITE CARE, AND MOVING EXPENSES. AIR FORCE FAMILIES CAN ALSO RECEIVE HELP DEVELOPING A FAMILY BUDGET IN AN EFFORT TO STAY ON TOP OF THEIR FINANCES AFTER THE ASSISTANCE IS PROVIDED. IN 2015, \$1.7 MILLION IN GRANTS AND \$6.4 MILLION IN INTEREST FREE LOANS WERE PAID OUT TO HELP AROUND 15,000 AIRMEN.

COMMUNITY ENHANCEMENT PROGRAMS - THE SOCIETY SUPPORTS SEVERAL BASE-LEVEL PROGRAMS AIMED AT IMPROVING THE QUALITY OF LIFE FOR AIR FORCE FAMILIES. FUNDING FOR CHILDCARE PROGRAMS WAS \$787,000 IN 2015 AS OVER 18,000 CHILDREN WERE CARED FOR THROUGH THE GIVE PARENTS A BREAK, CHILDCARE FOR PCS, AND CHILDCARE FOR VOLUNTEERS PROGRAMS. BUNDLES FOR BABIES PROVIDES EXPECTING FAMILIES INFORMATION ON BUDGETING FOR THE IMPACT OF A NEW BABY WHILE PROVIDING RESOURCES TO ASSIST ALONG THE WAY. IN 2015, 3,700 TOTE BAGS FILLED WITH BABY GEAR WERE GIVEN TO ATTENDEES OF THE CLASS AT A COST OF \$155,000. THE SPOUSE EMPLOYMENT PROGRAM PROVIDED ENTRY-LEVEL TRAINING TO OVER 1,000 SPOUSES DURING THE YEAR, COSTING \$225,000. OTHER PROGRAMS FUNDED BY THE SOCIETY WERE THE CAR CARE, PHONE HOME, AND HEART LINK PROGRAMS.

THE COMPENSATION COMMITTEE ALSO REVIEWS THE SALARY LEVELS, PROPOSED BONUSES, AND ANNUAL WAGE INCREASES OF THE OTHER OFFICERS AND THE FULL STAFF.
